COOKIE POLICY

Updated: 1 June 2023

This Cookie Policy (hereinafter referred to as the Policy) establishes the rules for the processing of cookies used by the data controller UAB Klaipėdos terminalo grupė (hereinafter referred to as the Company) on the managed Website https://www.ktgrupe.lt (hereinafter the Website).

1. What cookies are?

- 1.1. Cookies (small text documents with a unique identification number) are used on the Website a small text document containing a unique identification number that is transmitted from the Website to the visitor's computer or mobile device to distinguish the visitor's computer or other device, browser type, and view the visitor's online activity (time spent, pages opened, etc.). The unique number identifies the visitor's browser each time the visitor visits the Website. Cookies do not allow to memorize personal information (such as the personal name and address). Websites use cookies to for the purposes of statistics, such as the number and traffic of people visiting the Website. Such information is not linked to personal information. A visitor can disable the use of cookies (except for essential cookies) at any time, but without cookies, some Website functions may not work correctly or may not function at all. Cookies ensure a more convenient use of the Website, adapt the content of the Website to the specific needs of each visitor, and allow the Company to ensure the functionality of the Website and improve it.
- 1.2. No personal visitor data is collected through cookies.

2. Types of cookies

- 2.1. **Essential cookies** are used to ensure the functioning of the Website. These cookies are used to activate the main functions. Without these cookies, the Website would not be able to provide certain services, and the Website would not function as smoothly as it should. These types of cookies do not collect any information for marketing purposes and do not remember where the Website visitor has been.
- 2.2. **Analytical cookies** are used to collect anonymous statistical information and generate reports from which the Company can learn how visitors use the Website.
- 2.3. **Functional cookies** are used to remember visitor choices and settings (e.g., language). These cookies prevent visitors from changing their settings each time they visit the Website.
- 2.4. The company uses the following cookies:

- **2.5. Third party cookies** Third-party cookies from external providers are used on the Website. Visitors using these external providers' Websites must agree to the cookie policy of these external providers, which the Company does not administer or associate with. If the visitor does not click on the icons of these external providers' websites on the Website, no third-party cookies will be installed on their device.
- 3. Purposes of using cookies on the Website:

- 3.1. The Website uses cookies for the following purposes:
 - Ensuring the proper functioning of the Website and its features;
 - Analysing how visitors use the Company's Website.
 - Monitoring changes in Website traffic.

4. Legal basis for the use of cookies

- 4.1. The legal basis for the use of essential cookies is the Company's legitimate interest (Article 6 (1) (f) of the General Data Protection Regulation) in ensuring the functionality of the Website.
- 4.2. Other cookies are collected with the visitor's consent. (Article 6 (1) (a) of the General Data Protection Regulation).

5. Consent for cookie usage

- 5.1. Essential cookies are automatically installed, and visitor consent is not required. The visitor is informed of the use of such cookies.
- 5.2. All other cookies on the Website are activated only after the visitor agrees to their usage, i.e., these cookies are activated only after the visitor indicates their choice in the Website's cookie menu bar.
- 5.3. For each type of the cookie usage, the Company requests separate consent, which is given by the visitor through active actions in the cookie menu bar on the Website.
- 5.4. If the visitor does not express a choice regarding cookie usage, except for essential ones, cookies will not be installed.

6. Management of cookies

- 6.1. The visitor may withdraw or modify his/her consent at any time by clicking on the following link (active link).
- 6.2. The visitor can also delete the cookies by changing the settings of his/her web browser.
